COMPLETED Means, the day the report was run. Compliance Status will indicate simply by the run date and the secure clearance date.

12/13/2015

Original date of secured clearance. As of Run date, all good. However, will shortly expire.

5 years (60 Months) Clearances expire 5 years after secure date.

12/13/2015

Using this as an example, this clearance will expire on 12/13/2020

When one clearance expries per individual - they all expire. Secure all new - this way clearances are on the same timetable.

* Child Abuse History Clearance, the renewal window starts on the day after the 57 month.

Best Practices

- * Criminal History from PA State Police, the renewal window starts on the day after the 57 month.
- * Finger based FBI Criminal History Clearance, fees apply regardless of renewal window.
