How are we offering a whitewater rafting trip at Camp Trexler?

We've partnered with **Pocono Whitewater** to provide our Scouts with a Whitewater Rafting Adventure this summer! With the Lehigh River located right on our Camp's doorstep, we have the *perfect* opportunity to offer scouts this Rafting experience at one of the best rates.

What will Scouts experience?

Scouts of all skill levels will venture out onto the Lehigh River, guided by Pocono Whitewater river guides, and accompanied by Settlers Camp Staff. You'll paddle through 8 miles of Class, 1, 2, and 3 Whitewater rapids, traveling for around 3-4 hours on the river! Perfect for Scouts looking for an alternative to our Trexler Rangers Program on Wednesday Afternoon.

Schedule: Wednesday Afternoon-5pm. (Takes place during Trexler Rangers) Cost: \$35/Scout-Trips can be purchased prior, or at the Trading Post during your stay at Camp.
